## Job Summary:

The Grants Manager plans and implements organizational philanthropic activities; communicates efforts internally and externally with stakeholders; oversees budgets, financial tracking, analysis, and communication of results. The Grants Manager supports partners in community and affordable housing development efforts.

## Essential Job Functions:

#### **Function/Responsibility**

- Manage all organizational philanthropic activities. Develop and administer programs; establish and oversee processes for application, disbursements, reporting, monitoring, and compiling data.
- Develop material and provide training to stakeholders on opportunities, the application process, and grant compliance and reporting requirements.
- ✓ Conduct analysis of grant data; communicate program outcomes through reports, events, press releases, and speaking engagements; provide summary material to organization leadership.
- Provide outreach to staff, stakeholders, and broader community to educate about philanthropic efforts and to solicit feedback and visionary ideas.
- ✓ Oversee financial tracking and reporting process for impact investors and leadership.
- Conduct relationship management with investors and grant recipients to determine philanthropic needs and opportunities. Coordinate efforts with internal Capital Markets team to determine needs of Impact investors.
- Develop a network of developers, investors, local governments, philanthropic peers, and other key community partners. Develop unique impact investment strategies in coordination with these stakeholders.
- ✓ Participate in planning organizational conferences and events with a social impact perspective.
- ✓ Maintain understanding of regulatory environment along with industry trends and best practices. Share this understanding as appropriate with internal staff through reports or training.
- Participate in Development Department's technical support efforts to help partners with grant writing initiatives to secure funding for affordable housing developments. Maintain knowledge to provide support and training to partners in relationship to these efforts.
- ✓ Perform other duties as assigned.
